Rules & Information

- ❖ Children are accepted from birth to age thirteen (13) years.
- ❖ Registration is made in advance and in person by parent/legal guardian accompanied by the child.
- ❖ **The registration fee is \$24.00 and is non-refundable (already reduced by CWELCC)**
- ❖ Mother of Carmel Childcare Centre is open Monday to Friday from 7:00am until 6:00pm sharp **(children must be picked up by 6:00pm)**

** As part of our Safe Arrival and Dismissal Policy, parents are to notify the Centre at (905) 303-1000 if their child will be late or absent for any reason. Alternatively, if possible, notify staff the night before. Parents can also email smcdaycare@rogers.com to notify of changes. Please also note - If a child is not picked up by this time and with no word from either parent, an emergency contact person will be contacted. If by 7:00pm the child is still at the centre with no contact person reached, Local Police will be contacted. **

Fees

Our centre continues to be part of the CWELCC Funding (Canada Wide Early Learning) by the Province of Ontario. In an effort to lower the cost of childcare, parents will receive a reduction in fees, with the full fee reduction aimed for 2025 and parent fees averaging \$10 per day.

In addition to this funding, our Centre also receives a reduced rate via the Fee Incentive on behalf of York Region.

****All fee-based programs offered by York Region (Rate Incentive and CWELCC) do not apply to children aged 6yrs and above*****

Rate incentive is separate from the CWELCC provided by the Province.

Summer Program operates during the months of July and August.

- Fees are due in full regardless of children attendance.
- Fees are to be paid in full and in advance of the week attending.
- Payment may be made by cash or cheque, every Monday morning
- A charge of \$40.00 will be charged for cheques returned NSF.
- Returned cheques must be paid in cash and in full immediately

***If your child is to be absent for the entire summer, a two-week holding fee is required to hold the space**

EACH CHILD MUST BRING IN THE FOLLOWING:

- One small blanket to be used for naptime. **This will be sent home every week for laundering, and is to be returned the following Monday morning.**
- Each child must have a bag with one complete change of clothes including undergarments and socks. This bag is to be hung up in the child's cubby and should be taken home every Friday as well. All children's clothing and belongings **must** be labelled with their name to avoid any mix-ups.
***** It is important that these bags are maintained throughout the year and fresh clothes are added as others are used. This is the parent's responsibility. In the colder seasons, please provide your child with the appropriate outerwear: snowsuit, hats which cover their ears, warm scarves, boots and mittens. *****

Indoor and outdoor shoes are mandatory for the daily cleanliness of the centre

- Socks must be worn at all times
- Open toed sandals are not allowed

We stress an appropriate learning environment, good health and nutrition.

- ❖ A nutritious, hot lunch is served every day in addition to mid-morning and afternoon snacks.
- ❖ **We are a NUT-FREE Childcare Centre.**

*In our best effort to control exposure to allergens or food born illnesses, all foods served to the children must be prepared by the Centre or be purchased from an **Approved Source**.*

*An **Approved Source** is a food premise that is inspected by the appropriate federal, provincial or municipal inspection agency. **For example, supermarkets and bakeries are Approved Sources.***

For this reason, food that is made in the home of a parent or staff is not considered to be from an Approved Source and is not to be served to the children.

**** No homemade food is permitted on the premises**
(with the exception of the Infant Room)

- ❖ Parents that wish to bring in something for their child's birthday must make sure that it does not contain traces of nuts or nut oils, must be from an "Approved Source" as noted above, have all ingredients listed on manufacturer label, readable, best before date marked and must be accompanied by a dated receipt.
- ❖ **** Please note that we are not responsible for any lost or stolen items. ****
We ask that parents discourage their children from bringing toys, gum, electronics or junk food into the Centre.
- ❖ Every first Monday of the month children are to bring in a box Kleenex. We appreciate your understanding since this is an item that gets used very quickly with young children.

**** The Centre reserves the right to withdraw a child from the program in specific instances where an agreement cannot be met between a parent and the director in regards to the child's behaviour, disciplinary practices, payment of fees, etc. ****

- ❖ In settings such as daycares, it is not uncommon for children to come into contact with infections such as chicken pox, pink eye, etc.... In these cases, the Ministry of Health states that we must separate these children and notify the parents. Children may return to the daycare only after presentation of their Doctor's certificate stating that they are safe to do so.
- ❖ **** Please note that we reserve the right not to accept a child on the basis of ill health when presented to the daycare.** *We ask that you as parents please pay close attention to your children and be on the lookout for any signs of contagious infections such as pink eye or chicken pox, etc., in an effort to keep other staff and children free from sickness.*
- ❖ As per Public Health guidelines – *Childcare Centres are only permitted to dispense medication from its original container with the child's name and Physician's information on original label.*
- ❖ The daycare will be closed on Statutory Holidays as they occur throughout the year. **In these cases, regular fees still apply.** The days are as follows:

We close for 2 weeks each July (third and fourth weeks) of each year. Fees will be waived for this closure. Centre maintenance will take place such as painting and carpet cleaning.

**** It sometimes happens that a child becomes ill and we are unable to contact the parents because information has not been updated.**

We ask for your co-operation to ensure your contact information is always up to date. If there is a change in address or phone number, or email, please notify us in writing immediately so your child's file may immediately be updated.

Our Centre has policies in place to mitigate risk and ensure that every effort is made to make certain your child receives the most professional care and attention while attending our Centre.
